## NOTICE OF ACTIVITY

### TRANS MOUNTAIN EXPANSION PROJECT BURNABY, BC

**Mid-September 2018\***

Trans Mountain is preparing for construction activities at its Burnaby Terminal, located at 8099 Shellmont Street (see map on page three), as part of the Trans Mountain Expansion Project (TMEP). The expansion of Burnaby Terminal is authorized by the National Energy Board (NEB) Order AO-001-XO-T260-010-2016. Subject to receiving necessary regulatory approvals and permits, Burnaby Terminal construction activities are scheduled to occur no earlier than mid-September 2018\* through to project completion.

Work at this site will include the following activities:

- Site preparation within Trans Mountain property boundaries, including the removal of trees and vegetation, installation of temporary infrastructure needed for construction, and the continuation of Relocation Activities as approved by the NEB in Orders XO-T260-003-2017 and MO-066-2018
- Installation of additional temporary access route into Burnaby Terminal
- Transportation of materials, equipment and personnel to and from the site
- Demolition of one existing storage tank and the installation of 14 new storage tanks within the terminal, resulting in a total of 26 tanks. Full-surface fire-protection systems and odour abatement equipment will be installed on all new tanks.
- Installation of ancillary infrastructure to support new storage tanks (e.g. pipeline manifolds, electrical cable trays, etc.)
- Installation of enhanced stormwater treatment system
- Relocation of four non-fish-bearing watercourses within the terminal to accommodate the new tanks, as approved under Section 11 of the Province of BC Water Sustainability Act

# NOTICE OF ACTIVITY

## TRANS MOUNTAIN EXPANSION PROJECT BURNABY, BC

Mid-September 2018\*

During the course of construction activities, the public may notice:

- Increased activity, construction-type noise and odours in proximity to Burnaby Terminal
- Intermittent, temporary traffic delays while moving equipment to and from Burnaby Terminal and during the construction of the secondary access
- Additional signage near the Trans Mountain Trail
- Additional directed lighting within terminal property boundaries

Trans Mountain's goal is to maintain safe work environments and minimize any impacts of these activities to the public and the environment. When work commences, the following measures to manage this impact will be in place:

- Hours of work:
  - Activities will mainly take place between 7 am and 8 pm Monday to Friday, and from 9 am to 8 pm on Saturday, in accordance with Trans Mountain's Noise Management Plan, as approved by the NEB
  - No work will take place on Sunday or any statutory holidays
- Dust from construction traffic will be controlled using best industry practices, including water trucks and street sweepers
- Lighting directed only on areas of work for worker safety
- Timing of tree removal will be completed according to NEB approvals
- Construction-related traffic will follow the site-specific Traffic and Access Control Management Plan to minimize impacts during peak hours
- Construction vehicles will not occupy off-site public parking spaces

Trans Mountain is committed to completing TMEP in a manner that minimizes impact to the environment, landowners and its neighbours. Trans Mountain conducts all work under Environmental Protection and Emergency Response Plans to ensure compliance with applicable environmental regulations and requirements.

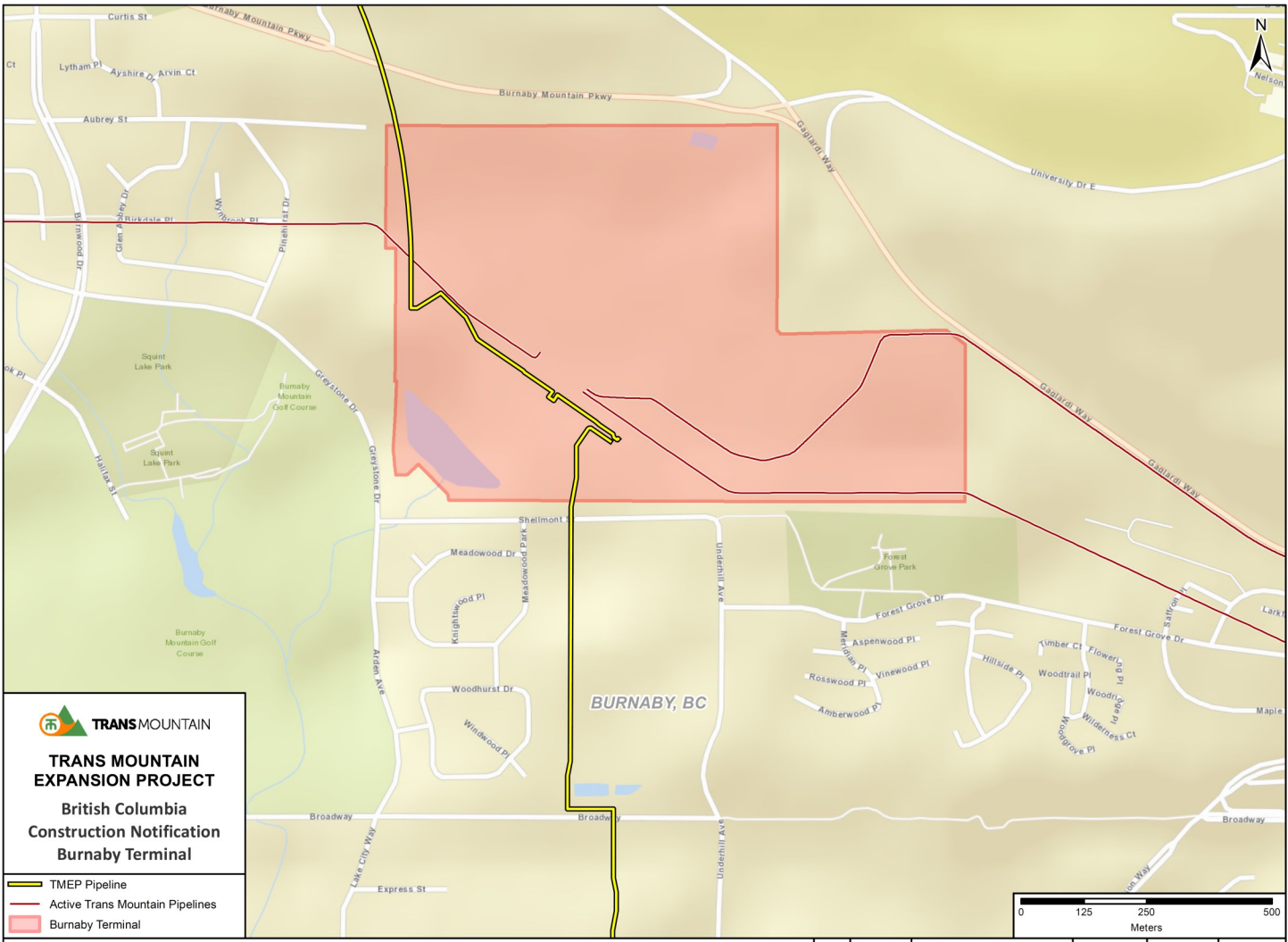
